# YOUR WINDRUSH & THE

DY
RICHARD REDDIE



It has often been said that alongside the Church and London Transport, the National Health Service (NHS) has been one of the major beneficiaries of the Windrush generation.


I know so many Caribbean women and men who have worked for the NHS as doctors, nurses, auxiliaries and the like. (Many of them were also Christians who helped to revitalise the Church on these shores. Indeed, in my church, virtually all the Black women over a certain age worked for the NHS in some capacity.) Likewise, my mother—in—law was recruited directly from Guyana to work in the NHS as a nurse, and in time she worked as a midwife at many of the leading hospitals in London.

That is why it was totally appropriate for members of the NHS to participate in the church-related events to celebrate the **75th anniversary of Windrush** on 22 June 2023. On that special day, the churches hosted a '**Walk of Witness**' which began at Waterloo Station in south London and ended at Southwark Cathedral, where a National Church Service took place in the afternoon.

The 'Walk of Witness' featured 75 walkers and 30 supporters, which included staff from the NHS, such as **Dame Ruth May**, Chief Nursing Officer for England, who

was one of the speakers at the gathering that took place before the walk commenced.

Similarly, NHS staff were also part of the groups who had their photographs taken at the Windrush Monument, alongside the specially created floral Windrush anchor, at Waterloo Station. Moreover, key personnel from the NHS



The NHS staff were also present at the amazing church service at the Cathedral, in which all attendees remembered the struggle of the Windrush generation; celebrated their successes; and shared their desire to see the next generation flourish in the future.

As we know, Black people from Africa and the Caribbean, as well as those from East and South Asia, remain the

mainstays within the NHS. It is hoped that events such as Windrush are appropriate reminders as to their invaluable and indelible contribution to keeping this country fit and healthy.

## Appointment of Darrell Redmond to new role of National Organiser for Black-majority churches

The aim of this brand-new role is to strengthen dialogue and relationships between Black-Majority Church (BMC) members and the Labour Party.

**Darrell Redmond**, firmly rooted in the Church of God of Prophecy (COGOP), has been appointed to the role of BMC National Organiser. He has a *w*ell-established background of previously-held community-focused roles at COGOP: in business, local government and not-for-profit sectors.

Darrell says: 'For decades, I have held the view that BMCs are a 'sleeping giant', waiting to be released to make an even greater contribution to civil society than it can already evidence. This may have been true decades ago but is no longer, and there was a view that Church and politics should never mix — even though every sermon from a BMC referring to Joseph or Herod has been preaching politics for nearly 75 years in the UK! Unfortunately, such sermons haven't always transcended into everyday life in Britain today. There are many unpublicised contributors to civil society from the BMC community.



As well as increasing dialogue and strengthening relationships, my aim is to collaborate with these churches and to seek opportunities to meet community needs and aspirations."

### Do you have a Social Housing Issue?

Know your rights, know how to complain. Everyone deserves a home that is safe, secure, and well maintained, so if you live in social housing, your landlord is responsible for fixing issues including damp and mould, leaks, broken locks or changes you need to your home if you're disabled. They can also help with anti-social behaviour, like noisy neighbours.

Know the steps to get an issue fixed:

Step 1. Report it to your landlord. Then, if it is not fixed...

**Step 2**. Complain through your landlord's complaint process, and if you're not happy with the final response from your landlord...

Step 3. Escalate your complaint to the Housing Ombudsman.

The Housing Ombudsman is **impartial**, **will investigate fairly** and can **order your landlord to take action**. Know your rights, **visit gov.uk/social-housing**
